The first editions of Seikel, King, and Drumright's Anatomy and Physiology for Speech, 1996 Language and Hearing and Roth and Worthington's Treatment Resource Manual for Speech-Language Pathology are published. 1999 Singular is sold to Delmar Publishing, a division of Cengage. 2004 Seeing a need in the field for a dedicated CSD publisher, the Singhs start Plural Publishing, Inc. Plural mourns the loss of its co-founder, Dr. Singh at the age of 76. Plural Publishing and Angie Singh establish the Plural Publishing, Inc. Research Awards in Honor of 2010 Dr. Sadanand Singh, which is bestowed by the Council of Academic Programs in Communication Sciences and Disorders (CAPCSD). Plural establishes the Student Research Forum Awards given out yearly to five students by the American Academy of Audiology, as well as the Sadanand Singh 2012 Memorial Scholarship, awarded to one minority or international student who shows exceptional promise in audiology research. 2014 ASHFoundation honors Angie Singh with the Spirit of Philanthropy Award. In a full circle moment, Plural releases the sixth editions of Seikel, 2019 Shipley, and Roth's bestselling textbooks after obtaining the rights back from Delmar Cengage.
